Relief Station Technician

ASSIGNED LOCATION: PHQ DEPARTMENT: Operations

ASSIGNMENT: Relief Station Technician **REPORTS TO:** Operations Manager

PURPOSE OF POSITION:

Maintain prime mission radar, communications-electronics equipment, and meteorological/navigational aids. Provide site support such as food services, logistics, housekeeping and administrative duties at Alaska Radar System (ARS) sites.

PRIMARY RESPONSIBILITIES:

- Perform scheduled and unscheduled maintenance tasks on the AN/FPS-117 radar systems in accordance with Operating Instructions (OI) under the direction and control of a Radar Specialist.
- 2. Complete scheduled and unscheduled maintenance on the following equipment in accordance with OIs, and other equipment as assigned.
- 3. Single and multi-channel ground-air-ground (GAG) radios in the Ultra High Frequency/Very High Frequency (UHF/VHF) ranges;
- 4. Automated Weather Observation Systems (AWOS), and other weather equipment;
- 5. Non-Directional Beacon (NDB), Distance Measuring Equipment, and other Navigational Aids (NAVAIDS);
- 6. Telephone systems;
- 7. Public Address systems;
- 8. Computer systems;
- 9. Supervisory Control Access Data Acquisition (SCADA) systems.
- Act as Communications Security (COMSEC) Responsible Officer (CRO) or alternate CRO for the site COMSEC account.
- 11. Maintain a safe and effective airfield environment for flying operations, to include conducting Bird Aircraft Strike Hazard (BASH) controls in accordance with applicable permits.
- 12. Act as site monitor/administrator for all assigned test equipment in accordance with Ols.
- 13. Perform site administrative duties, including maintaining Technical Orders and publications, downloading and distributing electronic communications, administering site visitor requirements, and administering postal requirements.
- 14. Perform site logistics requirements to include:
 - a. Tracking requisitions;
 - b. Breaking down and inventorying materials upon receipt;
 - c. Preparing material for shipment;
 - d. Documenting materials shipped including hazardous and dangerous goods documentation;

- 15. Maintaining logistics area in a neat, orderly and safe manner.
- 16. Perform food services duties to include:
 - a. Safe food handling and storage practices;
 - b. Preparing meals;
 - c. Cleaning and sanitizing food preparation areas and dining rooms;
 - d. Inventorying and requisitioning food services items.
- 17. Perform housekeeping duties to include:
 - a. Cleaning restrooms and common areas.
 - b. Preparing temporary lodging rooms.
- 18. Managing site laundry requirements.
- 19. Plan and coordinate work activities with other ARS personnel, sites and departments.
- 20. Be familiar with ARCTEC Alaska publications, policies, and procedures, and the systems, procedures, and equipment applicable to the job responsibilities.

SECONDARY RESPONSIBILITIES:

- 1. Observe and report weather conditions in accordance with military procedures at locations where required.
- 2. Perform administrative duties and maintain assigned workplace, materials, and equipment in a safe, secure, and neat condition.
- Assist in developing job-related training programs and provide training as required. Station 4. Notify the Operations Manager or Sector Lead concerning incidents or circumstances that could affect the performance of ARS mission systems.
- 4. Work cooperatively and constructively with customers, third party representatives and other employees.
- 5. Perform other duties as assigned.

CORE QUALIFICATIONS:

- 1. Successful completion of a recognized course in Electronics Engineering Technology or similar program of study from a recognized technical/vocational school. Course of study must meet minimum contract requirements.
- 2. At least two (2) years' experience and proficient knowledge in the maintenance and operation of the AN/FPS-117 radar.
- Successful completion of AN/FPS-117 OJT (on-the-job-training) and classroom training.
- 4. Successful obtainment of a Federal Communications Commission (FCC) General Radio Operator License (GROL) within 90 days.
- 5. Ability to speak, read and write English proficiently enough to complete all employment duties.
- 6. Working knowledge of computers and typical applications including word processing (MS Word), spreadsheets (MS Excel), and database (MS Access).
- 7. Formal training or demonstrated ability in food services, including menu planning and meal preparation for groups of 10 or more people.
- 8. Demonstrated ability in:
- Using the military supply system to requisition equipment, supplies, parts, and other materials;
- 10. Shipping materials using military or commercial air transportation;
- 11. Preparing, handling, and receiving materials.

- 12. Knowledge of military Technical Order management.
- 13. Strong problem-solving and interpersonal skills to enable effective interaction with co-workers and customer representatives.
- 14. Strong organizational skills and the ability to work independently.
- 15. Possession of a valid state vehicle operator's license.
- 16. Ability to obtain a final security clearance at the SECRET level.
- 17. Ability to travel in small aircraft and be prepared to remain overnight in small villages in substandard accommodations.
- 18. Current biennial CPR and First Aid Certifications.
- 19. Food Handler's certification.

SECONDARY QUALIFICATIONS:

- 1. Ability to obtain a current military weather certification.
- Certification or demonstrated competence in operating equipment required for logistics functions at the sites, such as forklifts and tool carriers configured for forklift operations.

PHYSICAL REQUIREMENTS:

The following physical activities are frequently required of a Station Technician: Balancing; bending; kneeling; squatting; reaching; sitting; standing; walking; climbing steep stairs; pushing; pulling; lifting heavy objects; grasping; communicating in person, by phone or through written correspondence; hearing; and seeing. Certain station technician duties may require repetitive motions. The noise level in the operating environment may require hearing protection.

REPRESENTATION OF POSITION
